Amendments to the Academic Ordinances, 2016 of MIT Art, Design and Technology University, Pune

CIRCULAR

It is circulated for information of all the Deans, Directors, Principals, Head of the Departments, Faculty Members, Non-teaching Staff, Students and all the concerned that some of the provisions of the Academic Ordinances, 2016 have been amended. Said amendments made by the Academic Council in its meeting held on 22.12.2018 and approved by the Board of Management and the Governing body in the meetings held on 22.01.2019 and 05.02.2019, respectively. Unless otherwise provided specifically, these amendments shall come into force w.e.f. 05.02.2019.

Amendments made and revised provisions after the amendment are given below

Amendment made:

- a. In the table under Ordinance 7.1, brief description be amended as follows:
 - Against letter grade "FR", brief description be would be "Fail due to shortage of Attendance"
 - ii. Against letter grade "F", brief description would be "Fail due to poor performance or unfair means"

Revised provisions:

Revised table under Ordinance 7.1 would be as follows:

Amendment made:

- b. O.16.1 and O.16.2 of the Academic Ordinances, 2016 be deleted.
- c. Following proviso be added to O.16.3 of the Academic Ordinances, 2016.

"However, in case of FIRST YEAR RESULT ONLY, DUGC is to scrutinize the result for overall performance (academic and non-academic) of students, analyse the result subject wise and overall semester wise and to recommend to the Vice Chancellor, through Dean of the Faculty, names of the students who fall below 4.5 SGPA/CGPA and deserve consideration whom they recommend to be promoted (with backlog) to second year"

Note: This will be effective from the Academic Year 2018-19 and this will be in case of UG students only and not to PG Programs.



d. After O.16.3 following clause (O 16.4) be added

"O 16.4 A student will be promoted to third year when he / she has passed all courses from first year and secured CGPA 4.5 or more in second year of the program. Also, a student will be promoted to fourth year when he / she has passed all courses from second year and secured CGPA 4.5 or more in third year of the program. Likewise for promotions to fifth year and onwards same rule will be applicable.

Revised provisions:

Revised Ordinance 16.3 would be renumbered as 16.1 and it would be as follows:

16.1 Yearly Promotion: Promotion of a student from an even semester to the next higher (odd) semester is subject to the condition that the student must have secured a CGPA of AT LEAST 4.5 at the end of the academic year (after considering the results of the semester end Make-Up Examination and the Summer Term after the completion of the even semester, if applicable). A student will have to repeat the year if she/he fails to satisfy this condition.

Provided in case of FIRST YEAR RESULT ONLY, DUGC is to scrutinize the result for overall performance (academic and non-academic) of students, analyse the result subject wise and overall semester wise and to recommend to the Vice Chancellor, through Dean of the Faculty, names of the students who fall below 4.5 SGPA/CGPA and deserve consideration whom they recommend to be promoted (with backlog) to second year"



Note: This will be effective from the Academic Year 2018-19 and this will be in case of UG students only and not to PG Programs.

Newly added O 16.4 would be renumbered as 16.2.

Amendment made:

e. The words and figure "CGPA of 5.00" appearing in O.21.1 (b) of the Academic Ordinances, 2016 be replaced as "CGPA of 4.5"

Note: This will be effective from the Academic Year 2018-19.

Revised provisions:

Revised Ordinance 21.1 would be as follows:

- 21.1 A student shall be declared to be eligible for the award of the concerned degree/diploma if she/he has:
 - fulfilled the Minimum Credit Requirements for the award of the Degree/Diploma
 - (b) secured of minimum CGPA of 4.5 in the concerned Program at the end of the Semester in which she/he completes all the requirements for the Degree/Diploma
 - (c) no dues to the University, Departments, Hostels, Library, and any other such centers/departments of the University
 - (d) no disciplinary action pending against her/him.

Amendment made:

f. The words and figures "(d) CGPA of 4.50 to 4.99 shall be declared as Pass Class" be added after clause (c) in O.21.3 of the Academic Ordinances, 2016"

Revised provisions:

Revised Ordinance 21.3 would be as follows:



21.3 Award of Class:

The award of Class in all programs would be based on the CGPA in the concerned Program at the end of the Semester in which she/he completes all the requirements for the Degree/Diploma.

Classes will be awarded as per the following scale:

- (a) CGPA of 8.00 and above shall be declared as First Class with Distinction
- (b) CGPA from 6.50 to 7.99 shall be declared as First Class
- (c) CGPA of 5.00 to 6.49 shall be declared as Second Class
- (d) CGPA of 4.50 to 4.99 shall be declared as Pass Class
